

Polo for Learning Photo Contest

Photo Contest Rules and Regulations:

Agreement: The act of entering the Contest constitutes acceptance of the Contest Rules and decisions of the Contest judge. The contest is open to any individual who purchase tickets to the Polo for Learning Event on Saturday July 16th, 2011 only. Entries will be accepted in the form of a digital file copy submitted by email or dropped off at Henry's 267 Bank St. location by July 23rd, 2011. The digital file must be a jpg no larger than 8x10,

Contest Period: This Contest runs July 16th to July 23rd, 2011 only. Judging will take place on August 9th by local photographers from the community as appointed by the contest sponsor. The People Choices Award will be given to the entry that receives the most votes in the Gallery at 267 Bank St. From July 23rd - August 6, 2011 Winners will be contacted by a representative of Henry's and prizes will be available for pick up at Henry's Ottawa location only, 267 Bank Street, ON.
